Chairman and Deputy Chairman

Dr. Nadeem Ul Haque (RAC Chairman) is the Deputy Chairman of the Planning Commission, Government of Pakistan. He has held positions as a Division Chief at the International Monetary Fund (IMF) and as Director of the Pakistan Institute of Development Economics (PIDE). He received a Ph.D. in Economics from the University of Chicago and is known for his contributions towards economic policy development and reforms in Pakistan.

Dr. David Orden (RAC Deputy Chairman) is a Senior Research Fellow in the Markets, Trade and Institutions Division of the International Food Policy Research Institute (IFPRI) and Professor in the Institute for Society, Culture and Environment, Virginia Polytechnic Institute and State University. He received a Ph.D. in Economics from the University of Minnesota. His areas of research focus on agricultural policy and international trade.

Dr. Nuzhat Ahmad is the Director and Research Professor at the Applied Economics Research Centre (AERC), University of Karachi. She received a Ph.D. from the University of Sheffield, UK and specializes in issues relating to poverty, women and development economics. She has made extensive contributions to federal and provincial government's policy formulations pertaining to agriculture, public finance and urban development.

Dr. Imran Ali has been Professor of Economic History and Business Policy at the Lahore University of Management Sciences (LUMS) and has served as the Jamil Nishtar Chair of Agribusiness at LUMS. He received a Ph.D. from the Australian National University. His research focuses primarily on political economy, strategic management, agribusiness, and the history of agrarian and business development in Pakistan. From July 2012 he will be Professor of Business Policy at the new Karachi School for Business and Leadership (KSBL). He serves among others on the Boards of Pakistan Railways, the Dairy and Rural Development Foundation, and Al Razi Healthcare.

Dr. Kingsley Bash (ex officio member) is a Senior Research Fellow in the Development Strategies and Governance Division of the International Food Policy Research Institute (IFPRI). He is the Chief of Party for the Pakistan Strategy Support Program. He received a Ph.D. in Agricultural and Resource Economics from Colorado State University. His areas of interest included agricultural value chains and effective delivery of poverty alleviation programs.

Dr. Ali Cheema is an Associate Professor of Economics at the Lahore University of Management Sciences (LUMS). He received a Ph.D. in Economics from Cambridge University. He is currently a Fellow of the Institute of Development and Economic Alternatives (IDEAS) and the Center of Economic Research, Pakistan (CERP). He is also the co-lead academic of IGC, Pakistan. His areas of research include political economy, economic history, social protection, human capital and local governance.

Dr. Stephen Davies is Professor and past Chairman in the Department of Agricultural and Resource Economics at Colorado State University. He received a Ph.D. in Agricultural Economics from Michigan State University. His areas of research and teaching focus on agricultural marketing and trade, and international /regional development. He has worked in agricultural policy and water resources in Pakistan during his career.

Dr. Akmal Hussain is Distinguished Professor of Economics, FC College University, Distinguished Professor, Beaconhouse National University, and Senior Fellow, Pakistan Institute of Development Economics. He has advised the present Federal Government on economic policy as Chairman, Working Group on Institutions for Development, Panel of Economists and as Chairman of the Working Group on Poverty Reduction for Pakistan's Tenth Five-Year Plan. He received a Ph.D. in Economics from Sussex University, UK. Dr. Hussain has helped build organizations for overcoming poverty at the village, district, provincial and national levels in Pakistan. He has authored three books on development policy and has co-authored 26 other books on issues of poverty, peace and development.

Dr. Iqrar Ahmad Khan is the Vice Chancellor and Professor of Horticulture at the University of Agriculture, Faisalabad. He has established a Center for Agriculture Biotechnology and co-founded a German Academic Exchange Service (DAAD). He received a Ph.D. from the University of California, Riverside and has made extensive contributions towards agriculture and food security issues in Pakistan.

Dr. Sohail Jehangir Malik is a Visiting Senior Research Fellow in the Development Strategies and Governance Division, International Food Policy Research Institute (IFPRI) and the Chairman of Innovative Development Strategies (Pvt.) Ltd., a private policy consulting firm based in Islamabad. He received a Ph.D. in Econometrics from the University of New England, Australia. His research and policy advocacy focus on agricultural policy analysis, domestic commerce, rural finance, food security, nutrition, and social safety nets.

Dr. John Mellor is the President of John Mellor Associates, Inc., a private policy consulting firm. He was the founding Director General of the International Food Policy Research Institute

(IFPRI), and has served as the Chief Economist of the United States Agency for International Development (USAID). Dr. Mellor has been widely recognized for his work exploring the relation between rural development and sustained macroeconomic growth for poverty reduction.

Dr. Nicholas Minot is a Senior Research Fellow in the Markets, Trade and Institutions Division at the International Food Policy Research Institute (IFPRI). He received a Ph.D. in Agricultural Economics from Michigan State University and currently leads a research program on strategies for promoting the participation of small farmers in high-value agricultural commodity supply chains. He has published widely on agricultural market reform in Africa, fertilizer policy, fruit and vegetable markets, income diversification, and poverty.

Dr. Margaret McMillan is Deputy Director, Development Strategies and Governance Division of the International Food Policy Research Institute (IFPRI) and Associate Professor at Tufts University. She received a Ph.D. in Economics from Columbia University and has made a wide range of research contributions in the areas of international trade and investment focusing primarily on developing countries.

Dr. Syed Nawab Haider Naqvi is HEC Distinguished National Professor and the Director General of the Federal Urdu University of Arts, Science and Technology. He received a Ph.D. from Princeton University. He served as the Director of Pakistan Institute of Development Economics (PIDE) for nearly 18 years, was Professor of Economics and Chairman, Quaid-e-Azam University and OECD Professor at Middle East University in Ankara, and Heidelberg University, Germany. He is the Founder President of the Pakistan Society of Development Economists and has published on a wide range of subjects including econometric modeling, international economic policy, agricultural economics, comparative economic systems, and development economics and policy.

Dr. Michael Wyzan (ex officio member) is the General Development Officer for the Economic Growth and Agriculture Office at USAID/Pakistan. He received a Ph.D. from the University of North Carolina-Chapel Hill and has served as the Senior Agricultural Policy Advisor at USAID/West Africa, Accra, and Ghana. His areas of research focus on development economics, open economic macroeconomics, political economy and applied econometrics.
